ALL107.0/22 TENANT PARTICIPATION

Tenants raised the following issues: -

- a, Fly Tipping on WCT1 site continues, Town Clerk agreed to have it removed
- b. Discussion among tenants re water, water usage and cost.
- c. Confirmation that Hambleton Way will have its fencing replaced was requested
- d. ?when is WCT1 to have its fencing replaced
- e. Perimeter fencing WCT1 still needs to be done.

f. 24 out of 41 gardens on WCT1 not being cultivated and need to be asked to conform with tenancy agreement

- g. members begin inspections shortly.
- h. locks for both gates on WCT1 needed and keys

ALL 108.0/22 REPORT ON CURRENT ALLOTMENT ISSUES

a. No allotments have been issued over the Christmas period.

b. a number of repair issues are to be taken forward.

c. 30 posts have been purchased and being stored, it was agreed to have them delivered and stored. It was agreed to use the four posts currently in store on the WCT1 site.

d. tenancy renewals will go out early February.

ALL109.0/22 WATER CHARGE

Chair reported on the recent tenants meeting where the issue of water was discussed. It was clear from feedback tenants unhappy at the use of water butts. Tenants were happy to pay an increase in fee to accommodate the growing increase in water fees to the Council. A tenant had suggested the fees should be pro-rata to site and site usage.

It was proposed Clir. S. Sutherland, seconded Clir. M. Young and agreed to not proceed with the ware buts. it was prosed Clir. M. Young and seconded Clir. P. Davies and carried to recommend to Policy and Resources that the water fee be raised to £10 for the coming year.

It was also agreed to review the position in regard to water, water usage on sites.

ALL110.0/22 HAMBLETION WAY FENCING

The Town Clerk advised the tender process has commenced to provide the fencing in April. Costings to be agreed at March meeting.

Tenders to provide 400 meters of fencing at WCT1 to be considered at the April meeting.
